SITUATION

The land off Golds Lane is situated just to the west of the village of Tedburn St Mary. The village has a range of amenities including a shop/post office, two pubs and a primary school. The A30 is within easy distance linking Exeter and the M5 to the east and Okehampton to the west.

Extending to approximately 0.31 acres (0.13 hectares) the land off Golds Lane is a level enclosure bounded by hedgerow and fencing, situated between the popular villages of Tedburn St Mary and Cheriton Bishop.

The vendor has recently undertaken a programme of clearance on the land and it now presents a blank canvas for smallholding, equestrian or amenity/leisure use(stp).


