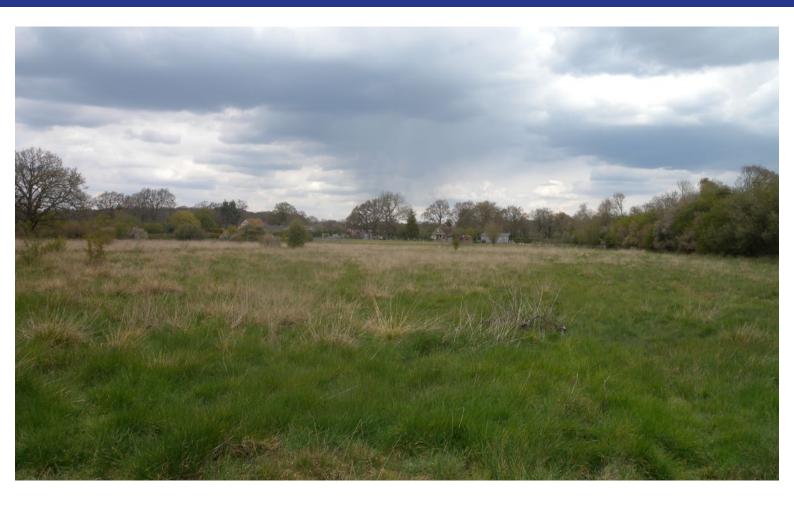

SITUATION

The land lies $1\frac{1}{2}$ miles to the north of Lingfield, Blindley Heath on the A22 is 3 miles to the west and to the east Edenbridge is 4 miles.

DESCRIPTION

LOT 1 - 1.50 acres (0.61 ha)

A useful grass paddock at the northern end of the road.

LOT 2 - 12.95 acres (5.24 ha)

An interesting parcel of accommodation land which could easily be brought back in hand. The eastern boundary is formed by the East Grinstead/Victoria railway line and the southern boundary by the Ray Brook. Substantial drainage dykes criss cross the land. Towards the south east corner is a pillbox with a water tank on the roof. There is another small building and lorry body. The cross hatched area refers to an area occupied by the vendor for many years.

TENURE AND POSSESSION

The land is offered for sale freehold with vacant possession on completion.

SERVICES (not tested and therefore not warrantied)

There is no mains water supply. A previous owner had an extraction licence for the brook to feed the tank on the pillbox.

RIGHTS OF WAY

Access to the land from the road is by right of way. If Lots 1 and 2 are sold separately a right of way will be reserved over Lot 1 to access Lot 2.

DIRECTIONS (RH7 6DF)

Turn off the A22 at the traffic lights into Ray Lane, follow down and then turn left into Lingfield Common Road which becomes Haxted Road. Follow under the railway bridge and shortly after turn left into Bowerland Lane on the sharp right hand bend and the right of way entrance will be seen on the left after ½ mile just after the next railway bridge.
