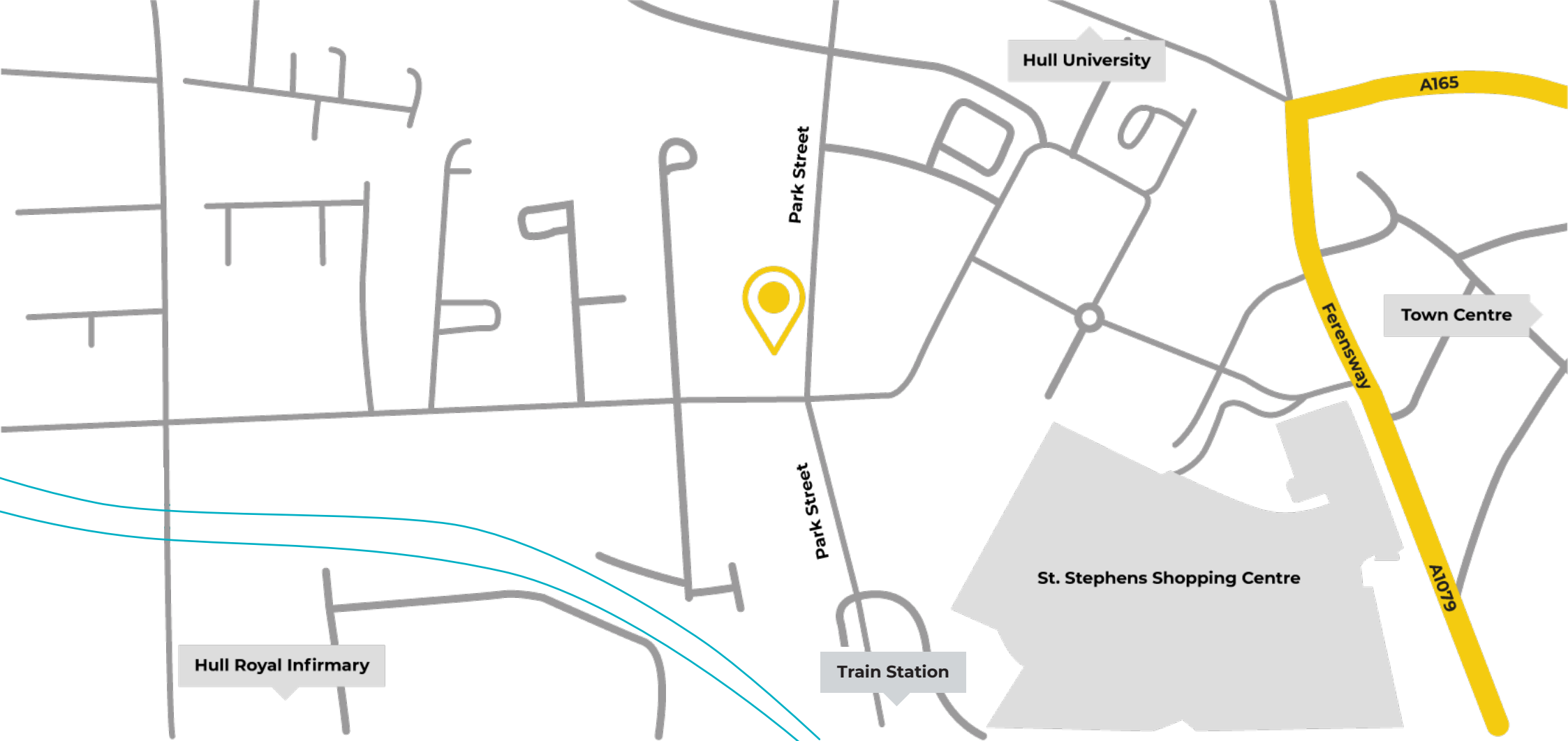

LOCATION
