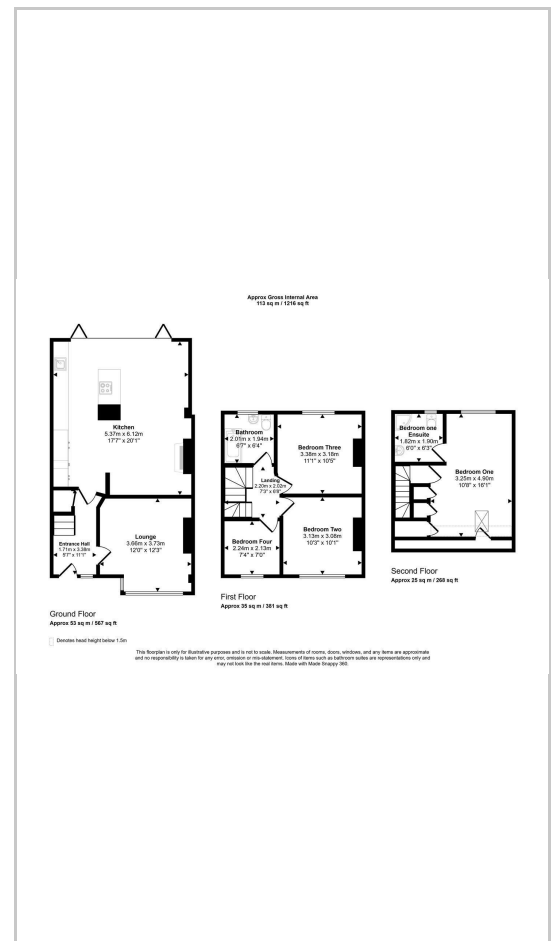

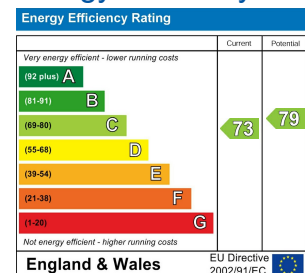
Area Map
