Harwood Cottage is an attractive period stone detached house set in the highly regarded village of Lastingham. Full of charm and character, the property enjoys an excellent position with beautifully stocked gardens, a paddock, and grounds extending in all to approximately **1.17 acres**. Offering comfortable accommodation, the cottage benefits from **oil-fired central heating, double glazing**, private car standing and a **double garage**.

The ground floor features a welcoming dining room with dual aspect bay windows at the centre of the home, a spacious sitting room with triple-aspect windows, and a well-proportioned kitchen with direct access to the garden. A useful ground-floor bathroom completes the layout. The first floor offers **four bedrooms**, including a generous main bedroom, enjoying garden and hillside outlooks and an adjacent bathroom.

Externally, Harwood Cottage stands within beautifully tended gardens, rich with mature planting, borders, lawned areas and sheltered seating spots. Beyond the main garden lies a hillside paddock—ideal for hobby use, small livestock, or simply enjoyed as extended green space. The double garage and driveway provide ample parking.

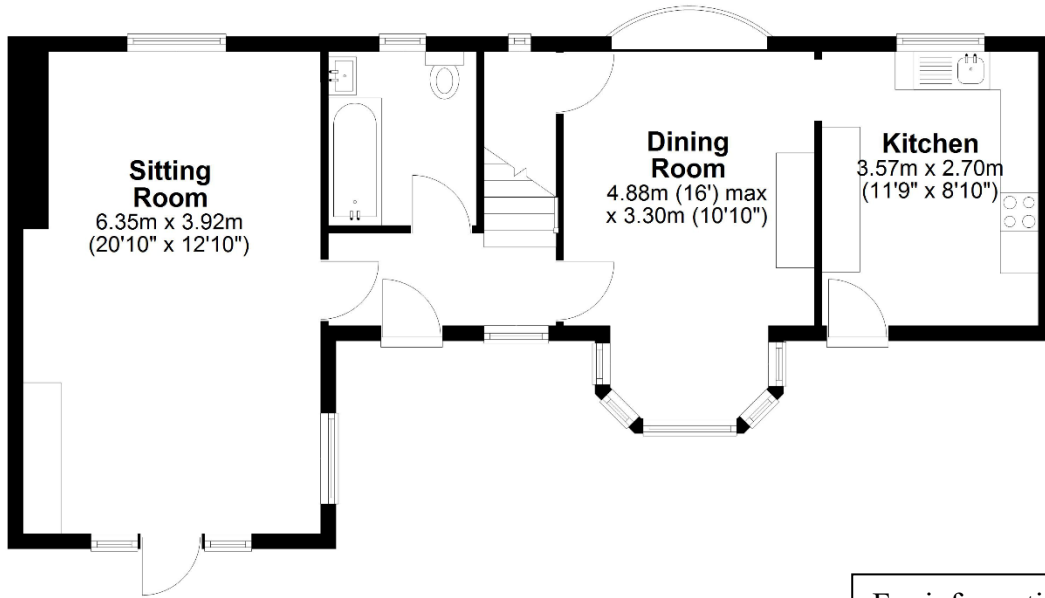
Lastingham is a picturesque village in the outstanding North York Moors National Park, known for its historic church, St Marys with its historic crypt, plus the four 'holy wells' or secret springs and scenic walking routes. A rare opportunity to acquire a charming period home with land in an exceptionally desirable moorland village—early viewing is strongly recommended.



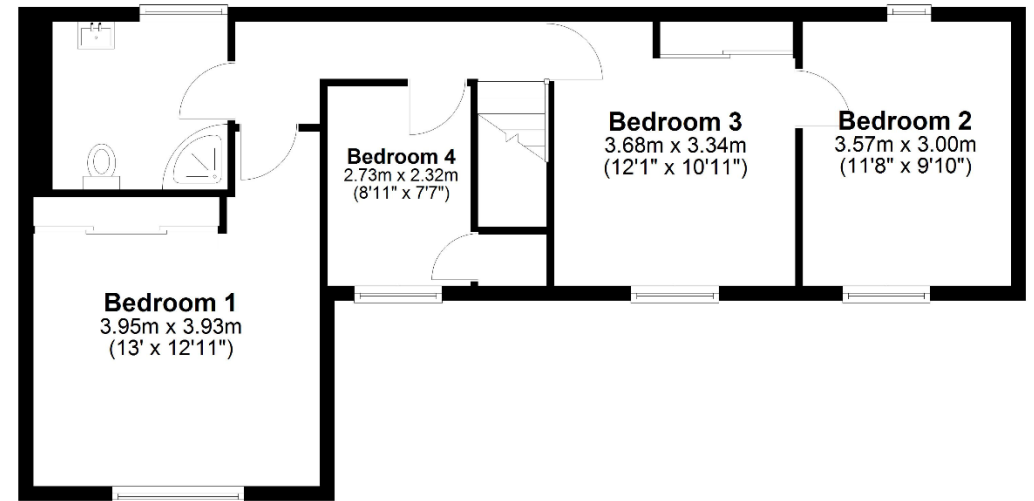
Ground Floor

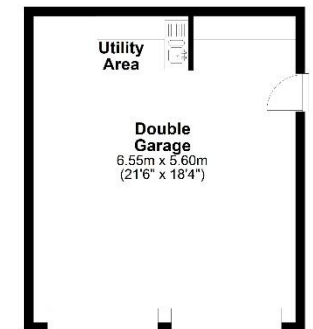

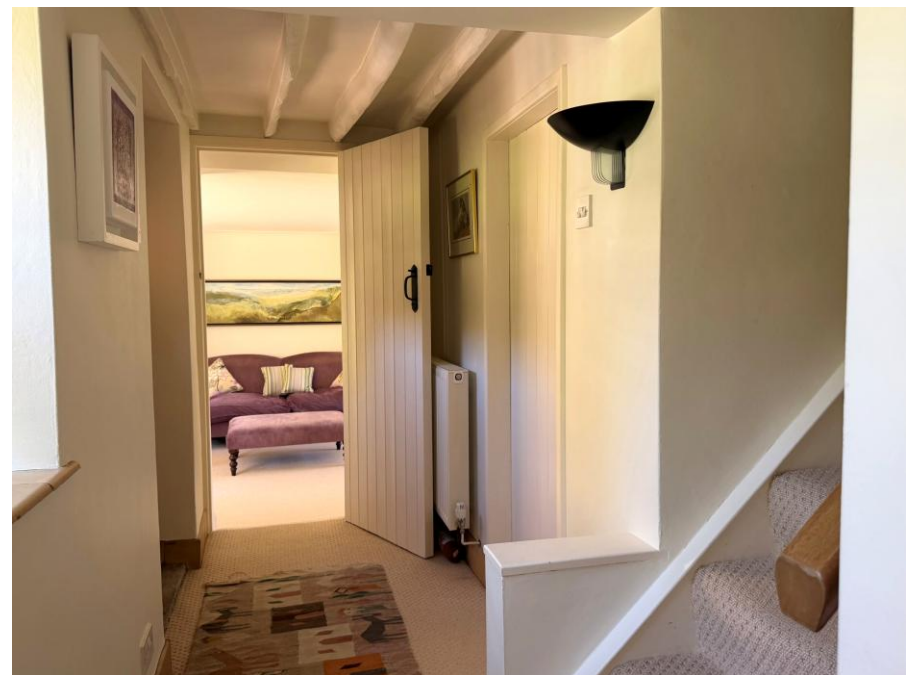
Ground Floor

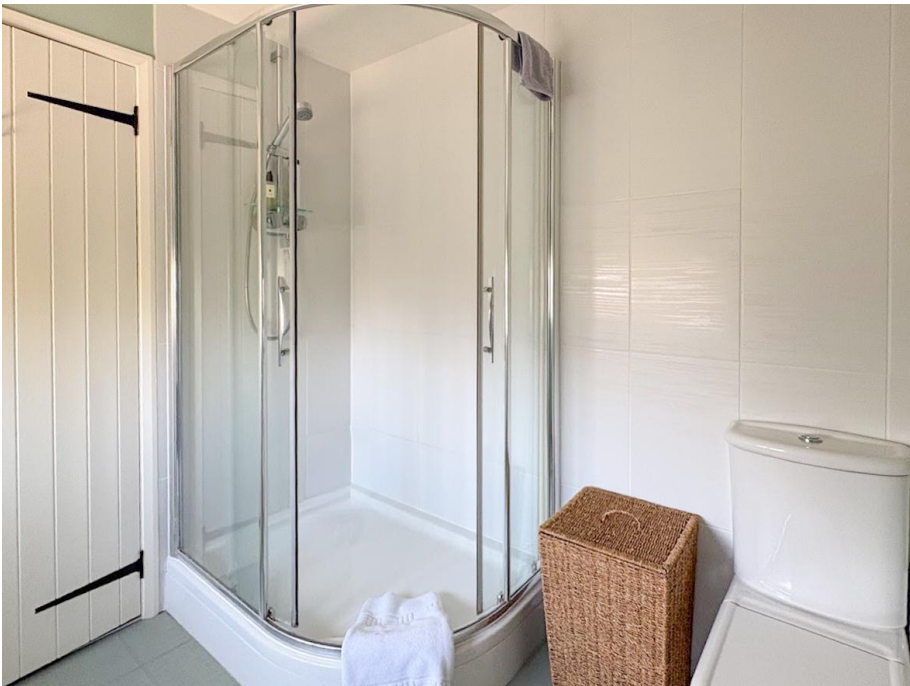
