Positioned on a generous corner plot with a good degree of privacy and plenty of off road parking, the property also benefits from gas central heating, replacement double glazing and rewiring. The kitchen has been refurbished with new doors and work surfaces, the downstairs cloakroom and upstairs bathroom have also been refitted. The stairwell has a glass balustrade allowing plenty of light and the living room has a wood burning stove for cosy winter evenings. A rear lobby gives access to the cloakroom and a small utility area which opens up to a useful dining/study/playroom with door out to the garden. To the first floor, there are 2 double bedrooms and the refitted 3 piece bathroom. The wrap around garden has shed & patio areas with raised beds and is enclosed by hedging and fencing.

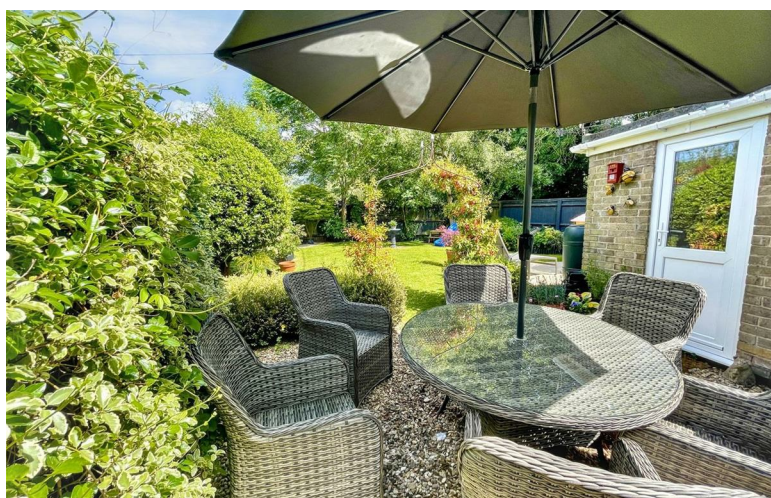

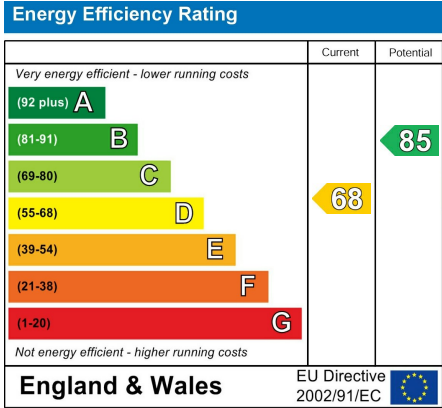
