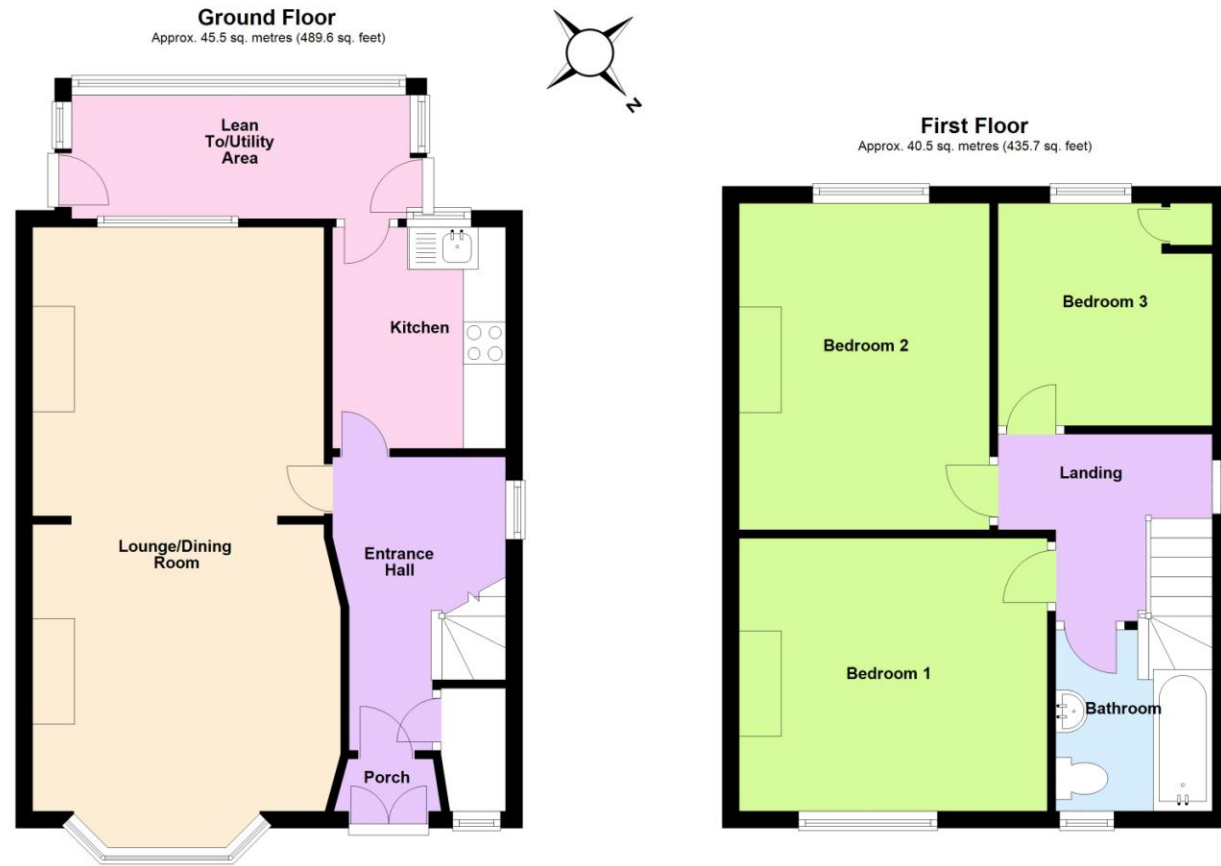

Offered with no upward chain and situated in one of Irthlingborough's most popular residential areas is this mature bay fronted three bed roomed semi detached property with features to include gas radiator central heating, uPVC double glazing, modern kitchen with integrated appliances and offers a 25ft lounge/dining room and off road parking. The accommodation briefly comprises porch, entrance hall, lounge/dining room, conservatory, kitchen, utility room, down stairs shower room, first floor landing, three bedrooms, bathroom, rear garden and a driveway.

Rear - Comprising concrete patio, main lawn, pathway, garden is enclosed by wooden panel fencing and measures approx 47ft n depth, outside water tap, brick storage barn, outside W.C.
