



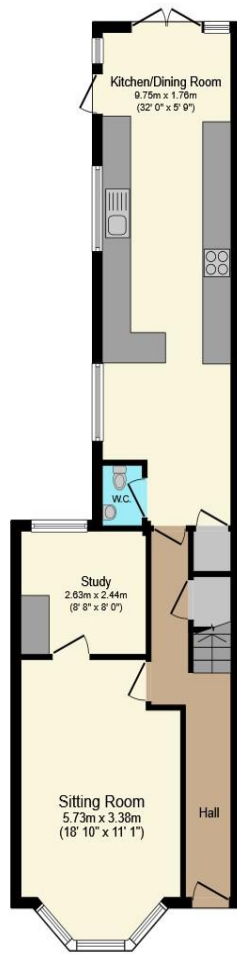

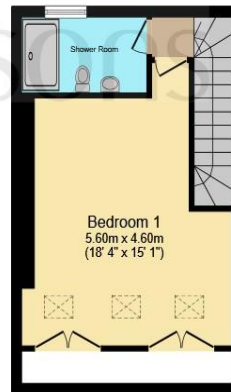




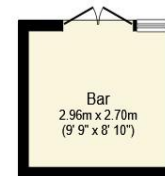
Ground Floor
