Offered with no chain is this three bedroom terrace house situated local to amenities and a short walk from the town centre. The property benefits from uPVC double glazing, gas radiator central heating, a refitted kitchen with built in appliances, a refitted bathroom, fitted wardrobes to two bedrooms and offers a third bedroom of 8' 7" x 8' 0", a ground floor cloakroom and utility room. The accommodation briefly comprises porch, entrance hall, lounge, dining room, kitchen, cloakroom, utility room, three bedrooms, bathroom and gardens to front and rear.
