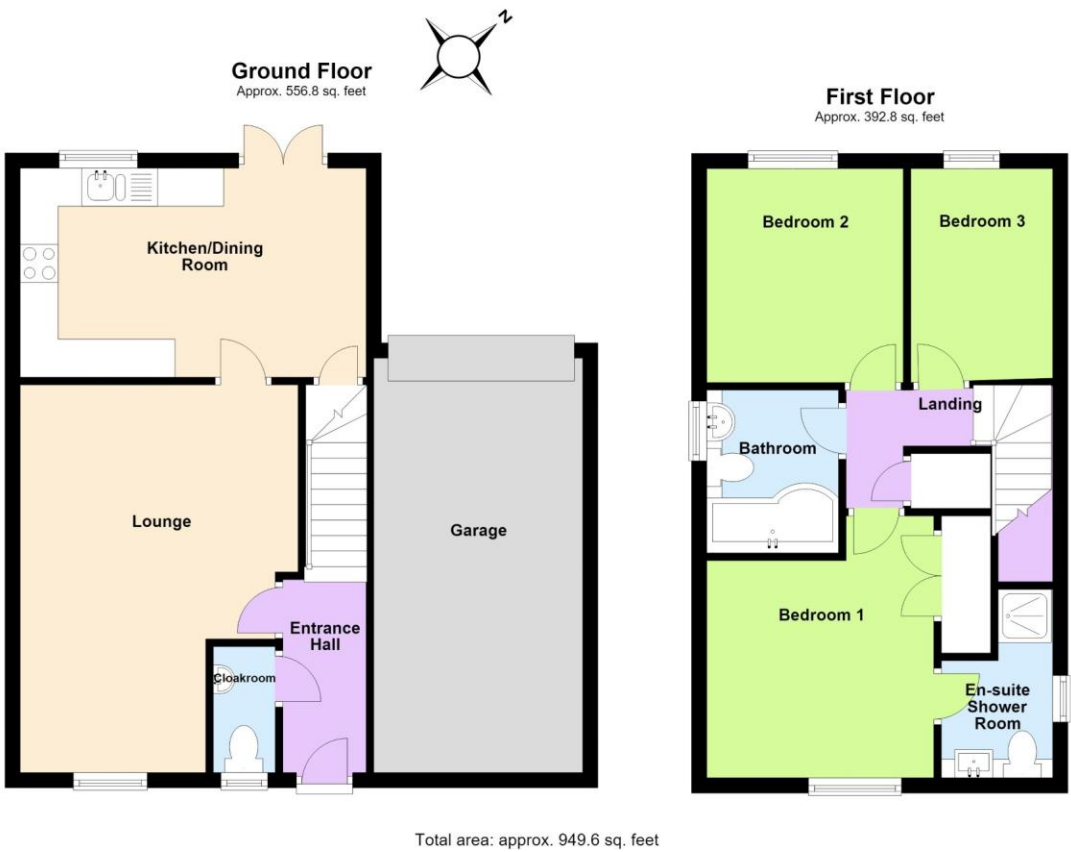

The accommodation briefly comprises entrance hall, cloakroom, lounge, kitchen/dining room, three bedrooms with en suite shower room to master, bathroom, front and rear gardens, single garage and a driveway.

Fitted to comprise one and a half bowl single drainer sink unit with cupboard under, a range of base and eye level units providing work surfaces, tiled splash backs, built in oven, gas hob, extractor, concealed wall mounted gas boiler serving domestic hot water and central heating systems, window to rear aspect, French door to rear aspect, plumbing for washing machine, fridge/freezer space, under stairs storage cupboard, radiator.

Refitted to comprise low flush W.C., vanity sink unit with cupboard under, 'P' shape bath with shower over, tiled splash backs, window to side aspect, extractor, heated towel rail.

Front - Laid with slate chippings, rear vehicular access to driveway providing off road parking for two cars, to:

Garage - Single, Up and over door, power and light connected.

Rear - Recently landscaped to comprise extended paved patio retained with wooden sleepers, step up to main lawn with border stocked with flowers and bushes, outside tap, gated rear and side pedestrian access, enclosed by wooden panelled fencing.
