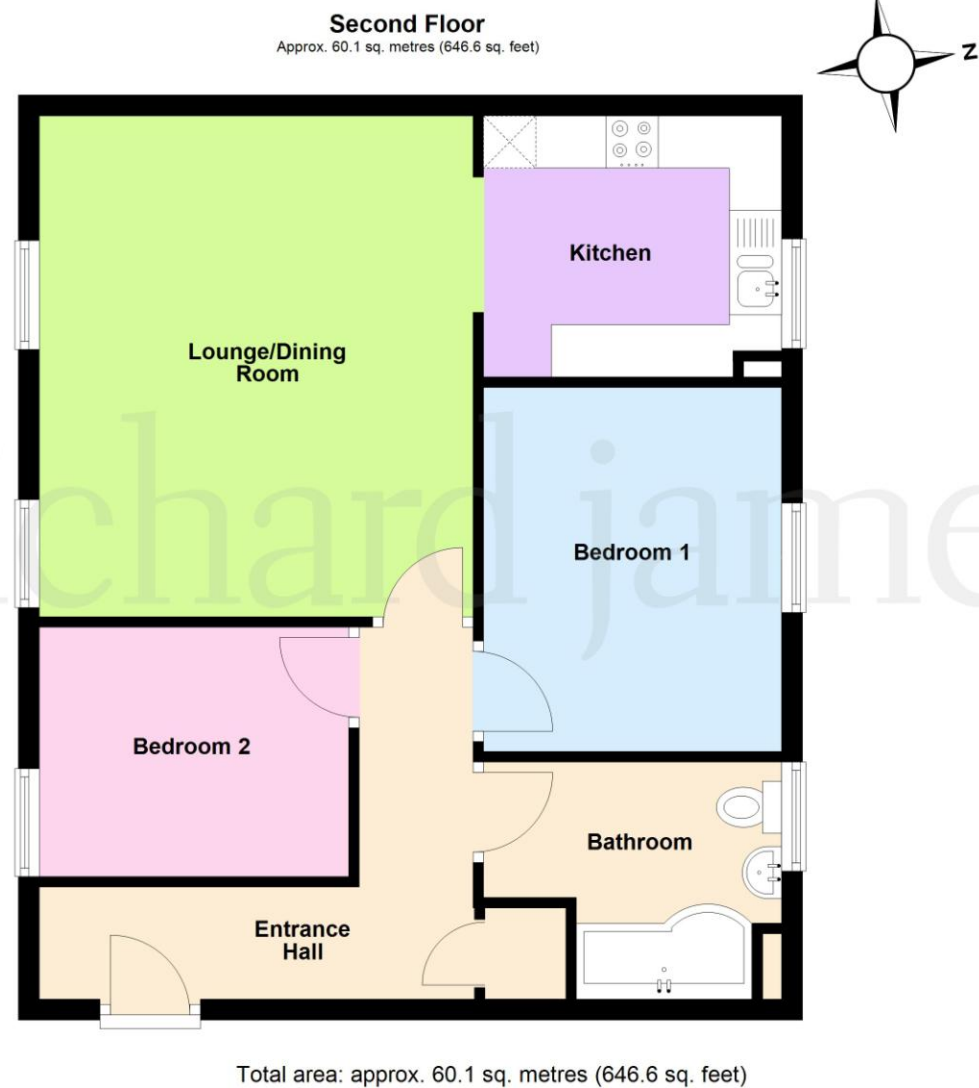

Situated local to the railway station, town centre and Castlefields park is this two bedroom second floor flat which benefits from benefits from uPVC double glazing, gas radiator central heating and built in kitchen appliances. The property further offers a 15ft lounge/dining room, two well proportioned bedrooms and an allocated parking space. The accommodation briefly comprises entrance hall, lounge/dining room, kitchen, two bedrooms, bathroom and allocated parking.
