



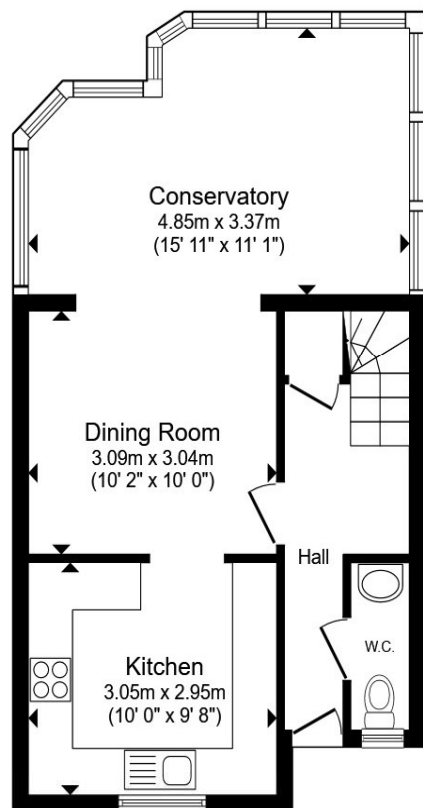

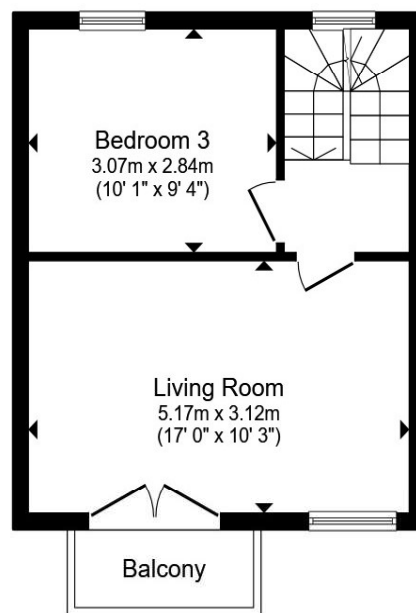

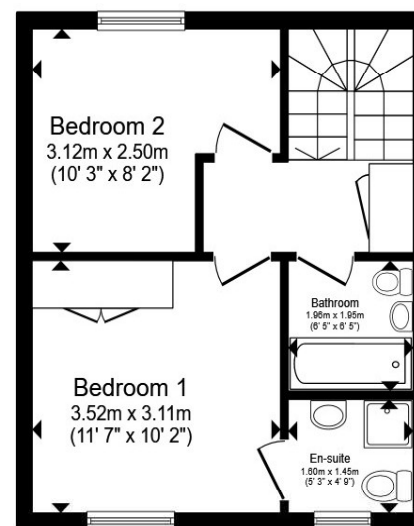




Ground Floor

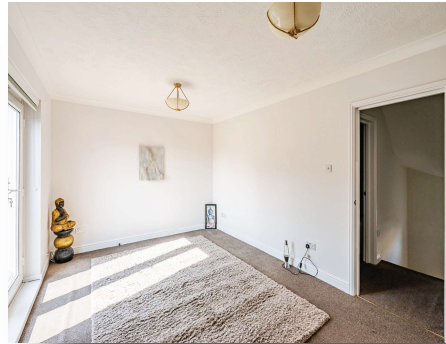
