



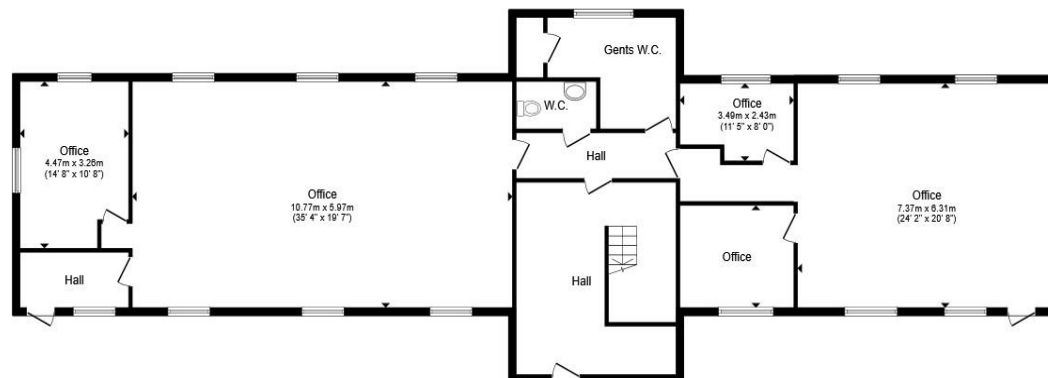

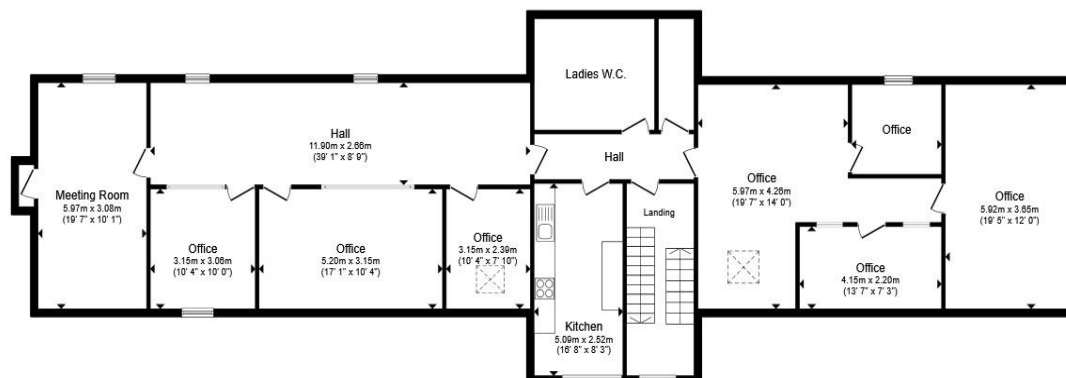

The Office Barn is a bright, self-contained detached building on the outskirts of Abingdon situated on the edge of Radley Village. The accommodation spread over two floors providing approximately 4,105 sqft (382.3MS) of space with far reaching views of open countryside to the front of the building. The overall plot is approaching 0.5 acres which includes a sizable parking area to the rear of the building which is accessed via secure gates.
