LOCATION

Ryhall Road industrial Estate is an established estate approximately 1 mile from Stamford town center. The warehouse has a full height electrically operated vehicle loading door and skylights throughout providing plenty of natural light.

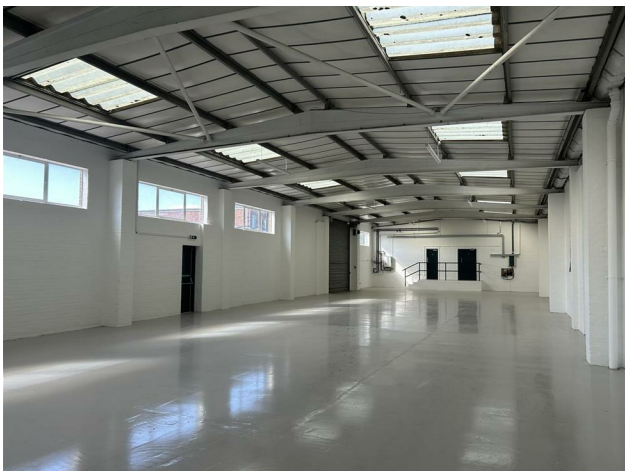
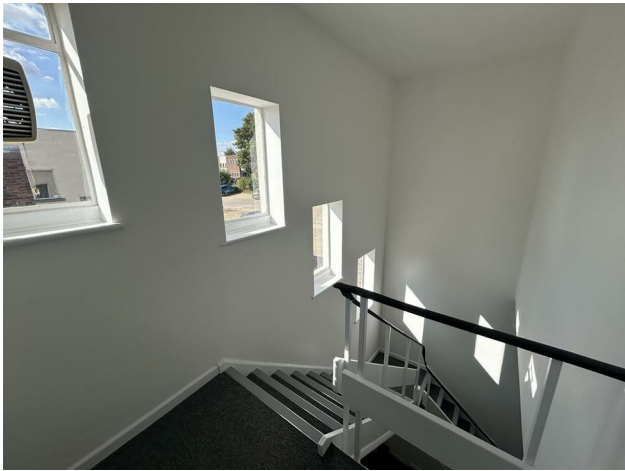

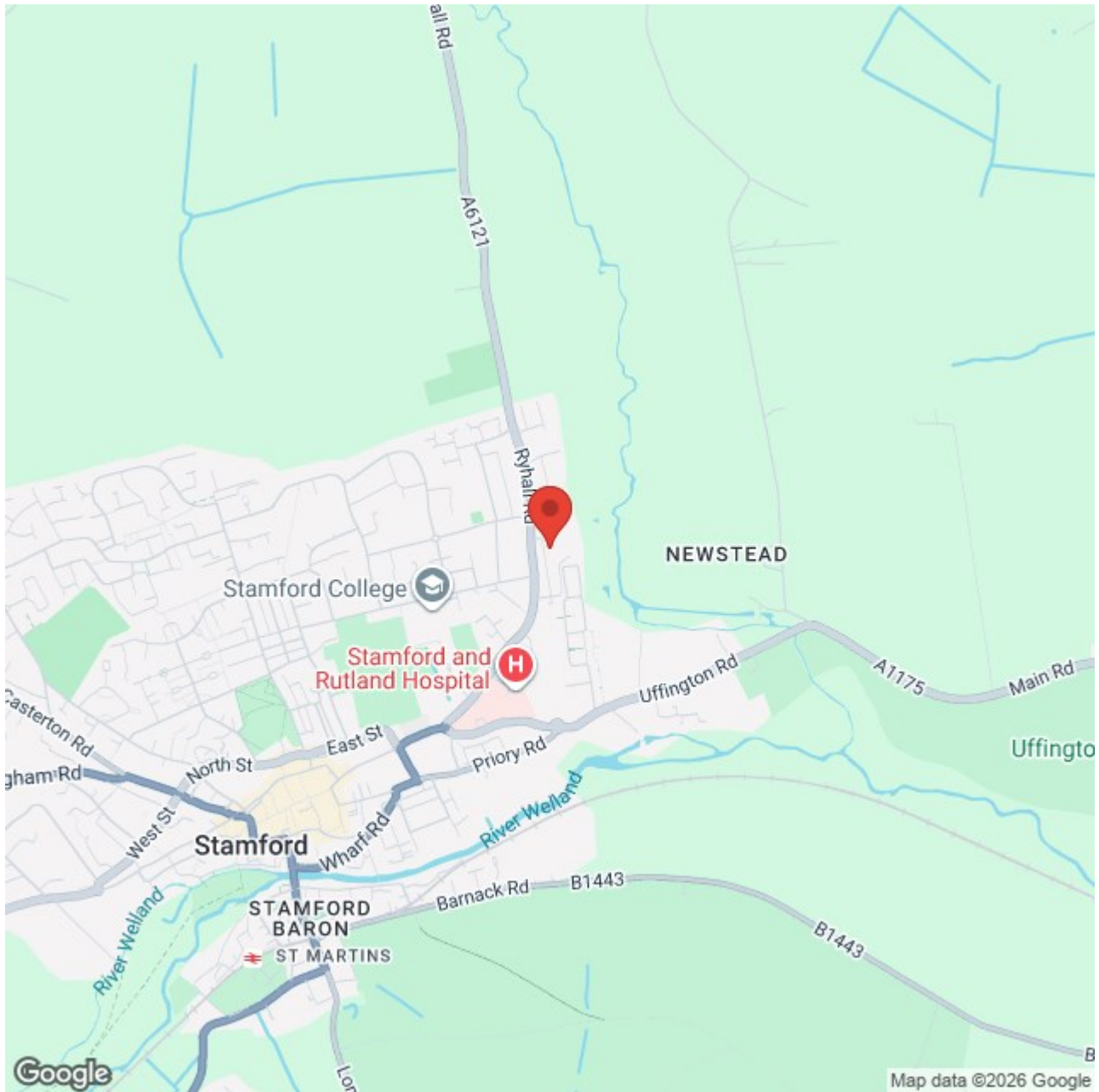
