



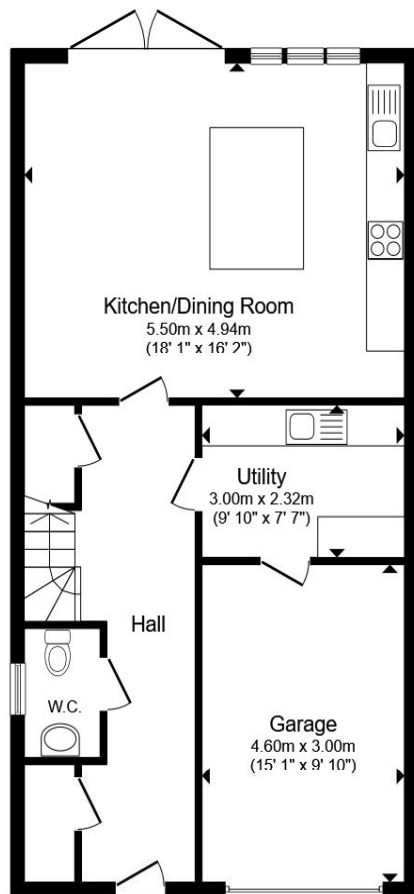

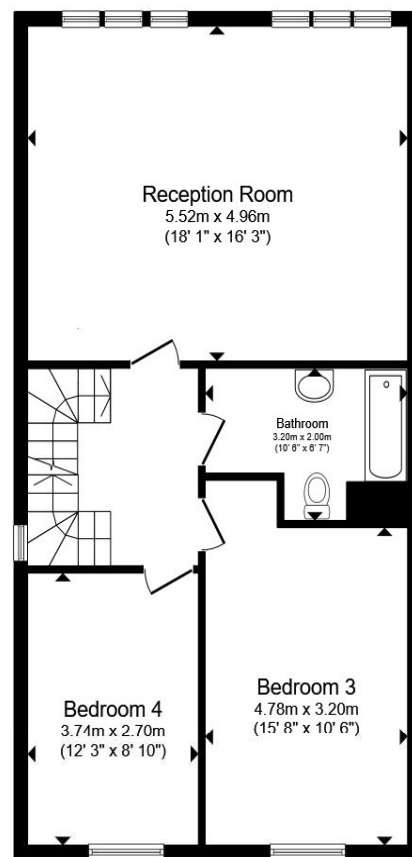

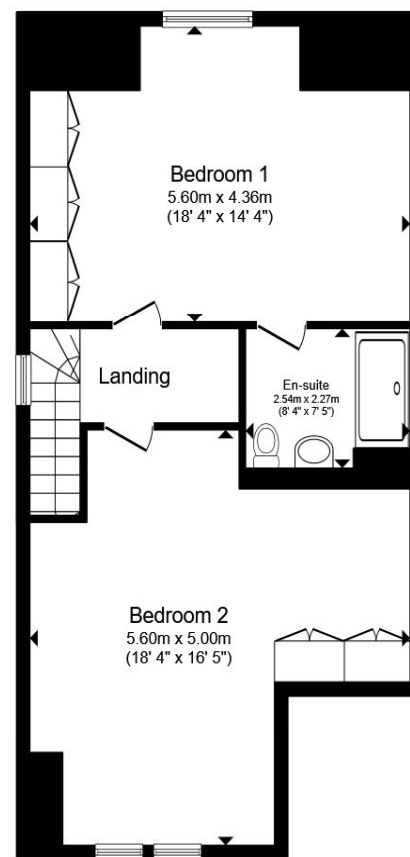




**Ground Floor**

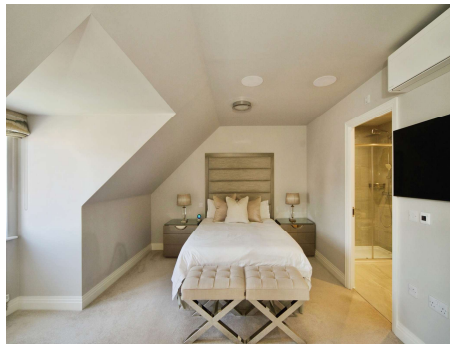
