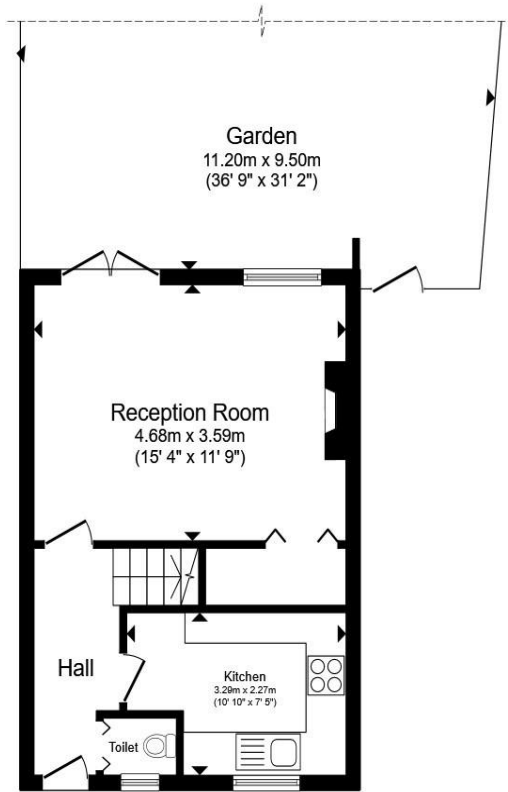
A well-presented three bedroom split level maisonette with large private west facing garden located within moments of Wimbledon Common and a short walk from Southfields Underground Station.

Comprising a large reception room with doors leading to a private rear garden, kitchen, three bedrooms, two doubles and one single, a family bathroom and downstairs wc.

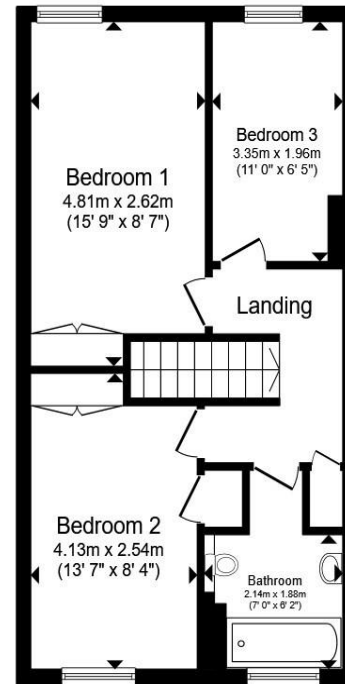
