Window to front. Shower cubicle. Low level w.c. Pedestal wash hand basin. Heated towel rail.

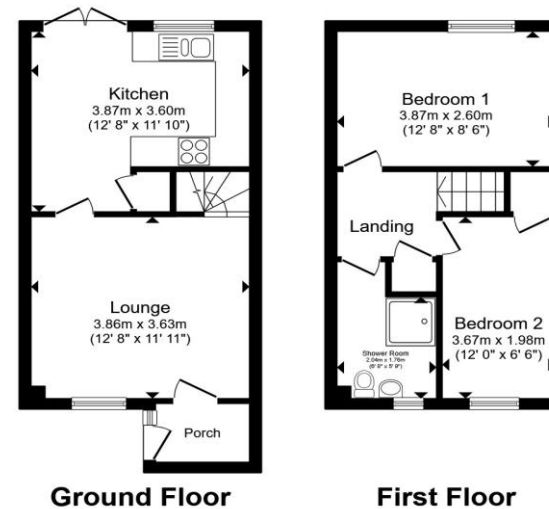
