Summertrees Road is conveniently located within walking distance of the parade of shops on Hope Farm Road which offers a wide range of amenities. The home lies within the catchment area for well-regarded primary and secondary schools making it an ideal choice for families. There are also great travel routes nearby.

The entrance hall leads to the lounge which has laminate flooring and a gas fireplace with a marble hearth and surround. The dining room has sliding UPVC doors to the rear, a double panel radiator and tiled flooring. The kitchen is fitted with a range of wall, base and drawer units, a stainless-steel sink and drainer, a large hob, double oven, an extractor hood, and a door leading to the rear garden. A convenient downstairs WC completes the ground floor.

To the first floor, the landing gives access to two bedrooms, the first benefiting from laminate flooring, a double panel radiator, fitted wardrobes and a large cupboard. The second has a fitted carpet, a double panel radiator, and a fitted cupboard. The fully tiled shower room comprises a shower, a pedestal wash hand basin and WC.

Externally, the property benefits from a private rear garden, while to the front there is a driveway providing off-road parking and access to the detached garage.

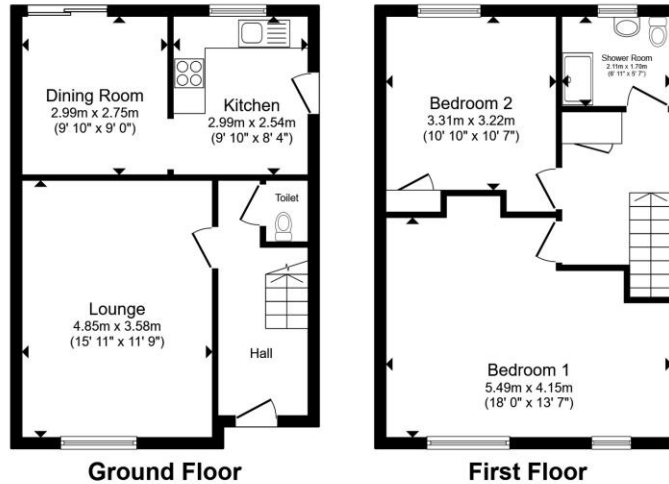
