



### FOOD CHAIN INFORMATION DECLARATION

**For all the animals listed on this document and for each holding from which they were consigned to the market, a declaration, signed by the keeper of the animals on each holding, has been received stating that:**

- The holding is not under movement restriction for bovine Tuberculosis (TB)
- Cattle on the holding are not under movement restrictions for other animal disease or public health reasons (excluding a 6-day standstill).
- Withdrawal periods have been observed for all veterinary medicines and other treatments administered to the animals while on this holding and previous holdings.
- To the best of my knowledge the animals are not showing signs of any disease or condition that may affect the safety of meat derived from them.
- No analysis of samples taken from animals on the holding or other samples has shown that the animals in this consignment may have been exposed to any disease or condition that may affect the safety of meat or to substances likely to result in residues in meat

### FARM ASSURANCE DECLARATION

**Cattle have resided on farm assured holdings for the last 90 days. Failure to affix a sticker and complete the declaration will result in the animals being classed as non assured at the time of sale.**

It is the responsibility of the vendor to provide true and complete details regarding farm assurance, in the case of any Farm assurance details provided by the vendor being incomplete or incorrect the purchaser of the lot/s may at their discretion lodge a claim, in which case the vendor will be liable.

### TB DECLARATION

Cattle entered for the store market will have to abide to the **PRE-MOVEMENT TB Testing Legislation**. The cattle listed overleaf will be of an age, i.e. less than 42 day's old or cattle from a 36 – 48 month testing regime holding that will have passed an official T.B. test in the last 60 days.

The animals listed have come from a holding that has had no movement of FMD susceptible animals onto it in the previous 6 day's (other than permitted exceptions). This Movement of animals complies with the relevant general licensing regulations as stated by the local authority.

**\*Please do not put Male on the form but Steer, Bull or Rig - Steers are sold warranted clean, Heifers are sold warranted maiden.** Calves must be at least 7 days old and have a completely dry navel and show no signs of scouring or ringworm.
