

## CHELSEA TICKET COMPETITION

1. The Chelsea Ticket Competition Prize Draw ("**Prize Draw**") is offered by Hamptons, a trading name of Countrywide Estate Agents, whose registered number is 00789476 and whose registered address is Greenwood House, 1st Floor, 91-99 New London Road, Chelmsford, Essex, CM2 0PP (the "**Promoter**").
2. Entry into the Prize Draw shall open at 4pm on 1<sup>st</sup> April 2022 ("Start Date") and will close at 5pm on 30<sup>th</sup> April 2022 ("End Date"). Entries received outside of these dates and times will not be considered.
3. Entry into the Prize Draw is open to eligible entrants only. An eligible entrant is one who is aged 18 years or over excluding employees of the Promoter and any persons who are connected in any way to this Prize Draw. Proof of age and identity may be required.
4. The Prize Draw is free to enter, but you do need your own active email account and access to the internet.
5. To enter the Prize Draw you must complete and return the Chelsea Competition entry form between the Start Date and the End Date.

10. There will be three prize ("Prize") winners in total. Two winners will win 2 day tickets each to the RHS Chelsea Flower Show 2022, including two 'Le Sunflower' dining experiences at Raymond Blanc's Jardin Blanc ("Prize 1"). One runner up will receive 2 standard day tickets to the RHS Chelsea Flower Show 2022 ("Prize 2").
11. The winner of Prize 2 will have the option of attending the RHS Chelsea Flower Show (the "Event") on either the 25<sup>th</sup>, 26<sup>th</sup>, or 27<sup>th</sup> May 2022. The winner of Prize 1 must be available to attend the Event on Friday 27<sup>th</sup> May 2022, and must arrive by 11am. The winners can only attend the Event once, on one day only. Prizes cannot be transferred to another date if you are unable to attend for any reason.
12. Prize 2 includes entry to the Event only. Prize 1 includes entry to the Event as well as a light breakfast, cookery demonstration by Raymond Blanc, champagne and a 3-course lunch (the "Experience"). 22. The Prizes may be subject to the Organiser's own exclusions and additional terms and conditions. Please contact the Organiser for further information and only accept the Prize if you are happy to accept the Organiser's terms and conditions.
23. The Promoter gives no guarantee or warranty regarding the Prizes. To the extent permitted by law, the Promoter, and its agents or distributors will not in any circumstances be responsible or liable to compensate the winner or any other person or accept any liability for any loss, damage, personal injury or death occurring as a result of taking up a Prize, except where it is caused by the negligence of the Promoter, its agents or distributors or that of their employees. Your statutory rights are not affected.
24. In the event of unforeseen circumstances (including cancellation of the Event by the Organiser), the Promoter reserves the right to amend or withdraw the Prize Draw at any time without liability.
