YMCA FUN RUN & FESTIVAL PRIZE DRAW 2022

- The YMCA Fun Run & Festival Prize Draw ("the Prize Draw") is administered by Hamptons, a trading name of Countrywide Estate Agents, whose registered address is at Greenwood House, 1st Floor, 91-99 New London Road, Chelmsford, Essex, CM2 0PP ("the Promoter").
- 2. Entry into the Prize Draw shall open on 11th April 2022 at 09:00 hrs (BST) and will close at 17:00 hrs (BST) on 8th May 2022 ("Closing Date"). Entries received outside of these dates and times will not be valid but any donation made on entry will still be processed.
- 3. Entry into the Prize Draw is open to eligible entrants only. An eligible entrant is one who is a UK resident who is aged 18 years or over excluding employees of the Promoter and any persons who are connected in any way to this Prize Draw ("Entrant"). Proof of age and identity may be required.
- 4. All proceeds of the Prize Draw will go to YMCA England & Wales (Charity Registration Number in England and Wales 212810.
- 5. Entries are made by either:
 - (a) Making a donation of £2.00 or more in-branch at a participating Hamptons branch or at the YMCA Fun Run on 8th May 2022 ("the Event") ("Entry Route A"). Entrants will be required to provide their name and telephone number ("Contact Details") and will be entered into the draw once for every £2 donated (e.g. £4 will buy two entries into the Prize Draw and £5.50 will also buy just two entries and not three entries); or
 - (b) Sending Contact Details via post to: Suky Pether, Hamptons 5 The Rookery, Kidlington, Oxfordshire. OX5 1AW ("Entry Route B"). Entrants must also provide their postal address in order to receive their physical ticket containing a unique entry number. Please note that Entry Route B is a free entry route into the Prize Draw, but Entrants will be responsible for the cost of postage. Postal entries must be received at least 48 hours prior to the Closing Date. Entrants will be entered into the Prize Draw once for every postal entry received by the Promoter.

Once an entry has been submitted it cannot be withdrawn or refunded.

All Hamptons branches located in North London are participating branches for the purpose of the Prize Draw. For further clarification as to whether a particular Hamptons branch is a participating branch, please visit Hamptons.co.uk/branches. Entrants can enter the Prize Draw as many times as they like using either or both of Entry Route A and Entry Route B.

- 7. Entrants will receive a physical ticket containing their unique entry number(s) and will be entered into the Prize Draw whereby the first 20 unique entry numbers drawn at random from all eligible entries received will be the winning entries.

third and will continue in this sequence until all prizes have been drawn. One prize per winning entry. The draw will take place at the Event on the 8th May 2022. There are 20 prizes in total.

- 9. Each winner of the Prize Draw will be notified, using the Contact Details they provided, within 7 days of the draw date. Winners will need to respond to the Promoter with their postal address for delivery of the prize where this has not been previously provided.
- 10. If a winner does not reply within 7 days of the notification in accordance with paragraph 8, he or she will forfeit the prize and another winner will be selected from the remaining eligible entries in accordance with the above process until a winner is selected and can be contacted.
- 11. The Promoter will endeavour to send the prizes to the winners within 30 days of the Event (subject always to the winners responding to the Promoter in accordance with paragraphs 9 and 10 above). Prizes will be sent by post to the winners and the Promoter accepts no liability for any lost, damaged or delayed prizes.
- 12. The prizes are not transferable and not exchangeable for cash or any other prize and if any prize is not available, the Promoter reserves the right to offer an alternative prize of a similar value.
- 13. The prizes are being supplied by external donators/suppliers ("Donors"). If winners encounter any problems with the enjoyment of a prize, please contact the Donor in the first instance. The Donor's terms and conditions will apply to the prize. Please contact the Donor for a copy of the Donor's terms and conditions and only accept a prize if happy to accept the Donor's terms and conditions. The Promoter gives no guarantee or warranty regarding the prizes.
- 14. The prizes will also be subject to Donors' exclusions and additional eligibility requirements. - 15. In the event of unforeseen circumstances, the Promoter reserves the right to amend or withdraw the Prize Draw at any time.
- 16. The Promoter may name the winners of the Prize Draw in subsequent related press releases and on their website. A list of winners (including their name and county) shall be available on request within 30 days of the Event by sending an email requesting the details to: pethers@hamptons.co.uk. By entering the Prize Draw, the Entrant agrees to their name being used in this way.

The only personal data the Promoter will process about the Entrants for the purposes of the Prize Draw are their Contact Details, proof of age and identity and postal address for the delivery of their tickets or prizes ("personal data").
