THE MAGIC MILLIONS FESTIVAL OF BRITISH EVENTING VIP TICKET COMPETITION

- The VIP Family Ticket Bundle at Magic Million Festival of British Eventing prize Draw ("Prize Draw") is offered by Hamptons, a trading name of Countrywide Estate Agents, whose registered number is 00789476 and whose registered address is Greenwood House, 1st Floor, 91-99 New London Road, Chelmsford, Essex, CM2 0PP (the "Promoter").
- 2. Entry into the Prize Draw shall open at 4pm on 13th June 2022 ("Start Date") and will close at 5pm on 15th July 2022 ("End Date"). Entries received outside of these dates and times will not be considered.
- 3. Entry into the Prize Draw is open to eligible entrants only. An eligible entrant is one who is aged 18 years or over excluding employees of the Promoter and any persons who are connected in any way to this Prize Draw. Proof of age and identity may be required.
