

TERMS AND CONDITIONS FOR THE NATIONAL LANDLORD INVESTMENT SHOW 2022 PRIZE DRAW

1. The [National Landlord Investment Show 2022] Prize Draw ("Prize Draw") is offered by Hamptons, a trading name of Countrywide Estate Agents, whose registered number is 00789476 and whose registered address is Greenwood House, 1st Floor, 91-99 New London Road, Chelmsford, Essex, CM2 0PP (the "Promoter").
