Please complete this form in full as it provides us with the information we need to process your application quickly and return it to us as soon as possible. Please print the details clearly and ensure email addresses are given. Your application can not be processed if it is not fully completed and signed.

Further to the implementation of The Tenant Fees Act 2019, the application process is entirely at the landlords' expense. Proceeding with the application is therefore at the landlord's specific instruction.

By law you are now required to provide evidence of your "right to rent" which will involve bringing suitable documentation into the office for us to verify and take a copy of. (Acceptable documents include; UK passport, EEA passport or identity card, permanent residence card, Home Office immigration status document.) Evidence is required for all adults over the age of 18 who will be living at the property either as a tenant or occupant. If you are unable to provide this information, please contact our office where we can advise on other documents which can be used as evidence. Again, your application can not be processed without this information.

Please provide three months current bank statements & three months wage slips (or a contract of employment), to enable us to carry out your references. If your credit score is low, then your application will not be processed any further until either supporting information or a guarantor is provided.

The Tenant Fees Act 2019 caps the deposit at no more than five weeks rent. To ensure that increased wear and tear on the property, as a result of having pets, is accounted for, we may negotiate a 'pet rent' at our client's discretion.

There is likely to be further interest in this property, so please note, that we may reference more than one applicant at a time. If you are unsure about the process or have any queries, then please do call us or visit our office and we will be pleased to assist you.
