STAGS STANDARD TERMS AND CONDITIONS

VENDORS COMMISSION – SPECIAL SHOW RATE (LOWEST EVER)

Commission will be charged according to the price achieved being: 5% per lot that sells between £1 to £1,000, 3.75% per lot from £1,001 to £5,000, and 2.5% per lot over £5,000 per item plus VAT. The commission is inclusive of all organising and advertising costs. There are NO ENTRY FEES but a minimum commission of £10 per lot will be charged for all lots sold.

DELIVERY OF LOTS

The sale site will be open for the delivery of lots on Monday 9th February from 10.00am-5.00pm and on Tuesday 10th February from 9.00am- 3.00pm. Any lots wishing to be listed online MUST be at the sale site by 12 Noon on Tuesday 10th February. A telehandler will be available to assist unloading larger items, the unloading of items is entirely at the risk of the vendor. Please note that the Auctioneers reserve the right to refuse or include items for webcast bidding at their discretion.

RESERVES

Must be submitted in writing to us prior to the sale commencing and cannot be adjusted upwards or indeed added thereafter. Any such instruction shall not be binding unless we have confirmed receipt of it in writing. We will not accept any reserves less than £100. We will try and let you know after the sale if your item has failed to reach its reserve price. Please ensure a mobile number has been written down overleaf so that we can contact you after the sale.

UNSOLD LOTS

All unsold lots must be cleared from the sale site by 3pm on Thursday 12th February. If a lot is unsold and the items are not collected from the sale site within the designated time there will be a clearance fee charged.

NO SALE, NO FEE

(T&C's apply) – Any items which are not sold, do not incur a commission charge.

PAYMENT

All lots sold in the Auction will be paid to the vendor either by cheque or by BACS. Payment will be made in a reasonable time frame. In the event of a dispute, Stags retain the right to withhold sale funds until the dispute is resolved. Where purchasers fail to pay within 2 weeks of the sale closing and all reasonable measures have been taken to ensure payment is made, Stags withhold the right to nullify any sale.

TITLE, HISTORY & FINANCE

Should a lot be proven to have been misdescribed/faulty by the vendor and subsequently the purchaser is refunded either from the auctioneers or from a credit card payment the vendor is liable to repay the monies back to the auctioneers. **Please note that s75(1) Road Traffic Act 1988 makes it a criminal offence to offer for sale motor vehicles or trailers which are unroadworthy unless defects are indicated to buyers.** All lots continue to be at the owner's risk until the auctioneers have received and cleared payment for each lot. The owner therefore remains responsible for insurance against loss, damage or destruction until that time. If any items have outstanding finance please write details on this entry form.

VAT

The Auctioneers operate a HMRC approved 'self-billing' system for VAT purposes. By entering items for sale, VAT registered Vendors accept this system, and agree not to issue tax invoices in respect of the transactions covered by this self-billing agreement for items sold and invoiced by Stags on your behalf. Furthermore, Vendors accepts full responsibility to account for and remit to HMRC any VAT collected by the Auctioneer on behalf of the Vendor. VAT will only be remitted to the Vendor upon receipt of a valid VAT number by the Auctioneer. The Vendor agrees to notify the Auctioneer immediately of any changes to their VAT status including; changes to their VAT registration number; cessation of VAT registration; selling the whole, or part, of their business.

TERMS OF BUSINESS, PAYMENT & CLIENT'S MONEY

I agree to be bound by the Onsite & Webcast Auctions Terms of Business as published on the Stags website. Payment will be made in a reasonable time frame of receipt of funds. The Auctioneers act as Agent in all financial transactions. Stags are registered with the appropriate RICS Clients Money Protection Scheme. As a RICS regulated firm we maintain exclusive control over the client money which is held in Stags Auction Client Account No 2, HSBC, 251 High Street, Exeter. The clients bank accounts are instant access accounts and Stags will cover transactional banking and account maintenance charges associated with the operation of such accounts, and is entitled to retain any interest earned through this client account.

TER CHECKING

All lots sold at £3,000 and above will be TER checked for theft and finance. A fee of £10 + VAT per check will be charged back to the vendor and deducted from the proceeds of the sale.
