There will be a show for the best pen of 20 or more Registered (1) Yearling Ewes, (2) Two Year Old and Upward Ewes. The Judges are Richard & Jono Thomas, Tanhouse Farm. Judging will commence at 9.30am promptly. All Ewes for the show must be penned by then, and the auctioneers must be notified by the vendor of the pen that they wish to enter in the show. One entry per vendor only.

Dilwyn Thomas, Maesrhiw Perpetual Memorial Cup will be presented to the winner of 20 Registered Beulah Ewes 2 Year Old & Upwards. A replica will also be given.
